# **ANSWERS TO PUBLIC QUESTIONS**

#### **Topic: Finance**

- Due to the lack of stadium upgrades, spectators were unable to use the bleachers for graduation, resulting in the need to order 550 chairs at a cost of \$1,622.50.
- School physician Dr. Vodges has been the school doctor for the past 10 years, but Cooper University Health System is no longer allowing doctors to provide this service. Her contract was for \$20,000. We contacted numerous doctors who were also unable to contract with the school district because of their association with Cooper. We also contacted Dr. Corrado, who agreed to the previous contract rate.
- · Voided checks The voided checks are not the same vendor. We have sent numerous requests and resupplied checks yet they remain uncashed.
- Annual bids go out every year for projects that cannot be completed by staff. The percentage over wholesale is the cost of any supplies for projects.
- Student enrollment numbers for the 24-25 school year at Cape May Technical School:
  - Regular Ed 168
  - Special Ed 39

#### **Topic: Food Service**

- The New Jersey Department of Agriculture monitors our compliance with the USDA requirements for National School Lunch and Breakfast Programs. At least 80% of the grains served in our school meal programs must be whole-grain rich. Whole-grain rich is a product in which 50% or more of the flour is whole grain. The flour used by many of our bakeries for our breads and rolls is considered a "white wheat" that is compliant with whole-grain rich requirements. It is a blend of whole grain and enriched flour. The white-wheat flour is a great way to introduce and make whole grains more palatable for students who are not used to eating them at home.
